
DOCTORAL RESEARCH SCHOLARS PERCEPTIVE ABOUT THE E-JOURNALS ACCESSIBLE IN MANONMANIAM SUNDARANAR UNIVERSITY LIBRARY AT TIRUNELVELI



ABSTRACT

E-publishing has revolutionized journal publication, subscription, access, and delivery mechanism. The researcher takes the initiative to analyze the doctoral research scholars' perceptive on the E-Journals accessible in Manonmaniam Sundaranar University Library at Tirunelveli. The researcher constructed a strong questionnaire and distributed the same to 150 selected doctoral research scholars. A simple random sampling technique is used to select the respondents. The researcher received 139 fully completed questionnaires from the respondents. The study revealed that the maximum number of respondents searched– journals by author wise and used the same for their research.

Introduction

Journals are an energetic source of information for research and development of the academic community. The number of periodicals at present-day is estimated to be 2,50,000. Journal names are increasing threefold every 15 years, and prices of journals are growing 2.5 times every ten years so that no single library can procure all journals in a discipline. With the advent of information technology applications, particularly the Internet, there has been a swing from traditional print journals to E-Journals. Electronic journals present remarkable possibilities and advantages over print journals; ease of use, "anywhere-anytime", accessibility, sharing ability, and hyperlinks to connected text or multimedia content. E-Journals also offer a solution to other major logistic problems faced by libraries, such as follow-up of missing issues, binding, shelving, etc. Online access to E-journals is available either free against a print subscription or for a nominal fee along with a print subscription. Such access is provided either by the publisher or through their aggregators.

Journals play a vital role in research and development activities. Most universities and special libraries spend most of their budget on acquiring journals. Due to the advent of information technology, paradigm shifts from print journals to e-journals have occurred in the past decade. Access to e-journals has enormous benefits to the subscribers; therefore, the university and research institutions are

subscribing to e-journals directly from the publishers or forming part of the e-journals consortium.

Profile of Sample Unit

Manonmaniam Sundaranar University Library was upgraded to a more digitalized version to synchronize with current trends in e-content. More than 4100 research theses are available for reference, and more than 1.5 lakhs of ebooks help academicians, research scholars, and students. As technology has improved, there is a provision in the library to read journals in various disciplines published by colleges/universities across the university. The library has secured 11th place among all Indian Universities in uploading 5142 awarded Ph.D. theses from our end under the "Shodhganga" project hosted by INFLIBNET. This

university has 1324 publications indexed in the Web of Science database and 5148 faculty publications in the Scopus database. The students can access the institutional repository from their place of stay with the help of a remote access method using their assigned password. The entire library is connected to a Wi-Fi facility. There are three specially designed computer systems with special facilities that help visually impaired students to avail the content without any difficulty.

Review of Literature

Natarajan (2017) studied the usage of e-journals among 182 students at Jimma University, Ethiopia. The study resulted that the usage of e-journals is increasing due to awareness among information science students about eresources and services. He has depicted that slow downloading is the major obstacle while using resources

Sohail and Ahmad (2017) compared e-resources and services utilized by faculty members and students of Fiji National University, Fiji Island. The study reveals that most users keep abreast of developments in electronic resources and services and their proper utilization in academics and research. The study has identified the users' problems in using e-resources and services, including inadequate IT infrastructure and blockade of websites.

Manonmaniam Sundaranar University invests a Sizeable amount in accessing e-journals attitude towards e-journals. 
Objectives of the study

updating their knowledge and 19 respondents (13.67 percent) for preparing their project.



- It is concluded that there is a significant association between respondents' perception of E-Journals accessible in the study unit and their satisfaction.
